² In case of lesson overlap between Comparative Business Law and all three courses The Art of Negotiation, Organizational Behavior, and Supply Chain Management, it will be possible to substitute Comparative Business Law with one of the other three courses.



- The list of courses to be taken abroad may be subject to changes should the academic offer at Paris Dauphine be amended.
- In addition to the courses listed above, students will be required to complete the Final Work (4 ECTS), according to Luiss' rules and with a Luiss supervisor.
- Students participating in this program may not be able to graduate at Luiss in July 2024 but will be able to do so in October/November 2024, provided they pass all exams.
- Exams passed at the partner university during the mobility period will be transferred to the Luiss career according to the Structured Exchange study plan. It is not possible to request an official renounce of the grades registration.
