Competition rules for the awarding of two scholarships to students admitted through their IB diploma scores to the first year of a bachelor's degree or single-cycle master's degree program at Luiss University for the 2024/2025 academic year.

As part of its initiative to value excellent students, Luiss University is offering **two of the 45 scholarships reserved to international students** to applicants who are admitted through their IB Diploma score to the 2024/2025 academic year.

The scholarships consist of a **full or partial waiver of the University's annual tuition fee** and can be renewed for the entire standard duration of the degree program.

1. Awarding of the Scholarship

The rankings will be determined based on the applicant's IB scores in descending order, irrespective of the degree program chosen. In the case of a tie, preference will be accorded to applications in the order in which they were submitted.

All students who apply for direct admission to the first year of a Luiss bachelor's degree or single-cycle master's degree program through IB scores in the 2024/2025 academic year are automatically considered for the award.

To compete for the award of the scholarship, students must allow Luiss to check final IB diploma scores directly on the MyIB platform. Students who fail to do so will not be considered for the scholarship competition.

2. Incompatibility

The aid envisaged by this competition is incompatible with other tuition fee waivers or scholarships held for any reason whatsoever, except for those awarded by Italian or foreign institutions designed to support, through periods abroad, a student's education for the academic years covered by this competition.

3. Renewal of the Scholarship

The scholarship will be renewed for the entire standard duration of the degree program on condition that the student, by the end of the summer exam session of the first year and subsequent years, has earned at least 70% of the education credits (*CFU*) required under their study plan for graduation purposes and has a weighted average grade of not less than 27/30.

4. Revocation

The aid envisaged by this competition will be revoked upon the occurrence of any one of the following:

- the student fails to enroll at Luiss University for the first year of a bachelor's degree or single-cycle master's degree program for the 2024/2025 academic year.
- the student no longer fulfills the merit requirements necessary for renewal for the second year, as specified in the preceding Article 3.
- the student enrolls as an off-track or repeating student.
- the student discontinues their studies.
- the student transfers to another university.

5. Submission of Applications and Publication of the Outcome

Students must allow Luiss University electronic access to their IB Diploma transcript to be considered for the award. Otherwise, it will not be possible to evaluate the student for the award of the scholarship.

Notification about the scholarship award will be sent to the applicant's e-mail in July 2024 after publication of final IB diploma scores. Therefore, students admitted in rounds 1 to 4 of the application process will be required to pay the first installment of the tuition fee to register; in case of award of the IB Honors scholarship in July, the first installment paid will be refunded after enrollment.

Luiss University denies all duty for applications that are not received due to technical faults or third-party reasons.
