### Important Rules

- This study plan is designed for students taking part in the mentioned Double Degree Program and spending the academic year 2024-25 at Nova SBE.
- Interested students are required to read and understand the study plan and its rules. These are to be considered binding to the successful completion of the double degree program.
- Changes to the study plan are usually not possible. Any request in this sense must be conveyed to the International Development Office and the Academic Coordinator, that will evaluate the request.
- The listed exams must be taken and passed in the academic year and at the school indicated in the scheme. Any possible change must be formally authorized by the Academic Commission.
- During the mobility, students will be subject to the rules of Nova.



- At the end of the program, if compliant with both Luiss and Nova academic requirements, students will obtain both the Master's Degree in Management (issued by Nova) and the Master's Degree in Management and Politics (issued by Luiss)

### **Thesis**

- Students will complete their theses with two supervisors, one from each university.
- The Master's Degree Project /Final Thesis is considered an individual work. At Nova, the only accepted format for Double Degree students' thesis is the "Directed Research" one.
- Students must respect the thesis procedures and deadlines from both institutions. Each institution will grade the final thesis according to its own standards.
- Students taking part in this program will need to defend the thesis in Luiss in one of the official available sessions, respectively in July, October/November and March/April.<sup>3</sup>
- In Nova, students will defend their thesis exclusively in their September session. At Nova, the thesis defense is an independent work that can be uploaded and discussed before completing all the required course in the Double Degree study plan (please refer to Nova guidelines for the specific credit threshold). Only after completing all the required courses in the Double Degree study plan and completing all the administrative procedures and requirements, Nova will issue the Master Degree to the student, upon the students' official request to graduate.
- Students are reminded that they are required to comply with the Luiss regular procedure regarding the thesis assignment, registration for the degree exam and upload of the thesis. For further information, please check the following [page](#). Similarly, students will also need to follow Nova procedures regarding the thesis and its defense.
